<b>REASON(S) FOR AMENDMENT</b> <p>During site walks for the 5 proposed tower locations, we discovered a more suitable site for one of the towers. The new site is approximately 3000 ft southwest of the original site on 420 Chamblin Road. The new site is approximately 120 feet higher in elevation and will provide better wireless coverage for the 800 MHz public safety radio system. The new site is on county own property next to I-20 and will facility broadband connectivity to the Georgia Department of Transportation weight station on interstate.</p> <p>The new site will provide better coverage for the city of Grovetown and western parts of the county in general. Additionally, the site will be located closer to areas of the county that have been designated 'unserved', which will allow for better coverage where service is needed more. Like all proposed sites in the project, the new site will be located on a county-owned property parcel which has already been developed.</p>
